

RIDER'S RELEASE AGREEMENT

WHEREAS, MAXIMILIAN HIRSCH AND DENISE C. HIRSCH d/b/a FLY HIGH FARM (hereinafter "FLY HIGH FARM") and ELIZABETH D. HIRSCH and NEW BEGINNINGS STABLE, LLC, have made available to the undersigned, or to the child of the undersigned, or both, all or a portion of any property, equipment, horses and facilities of FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, including, but not limited to, riding areas, stables, equipment, and horses, the undersigned hereby assumes full responsibility for the safety of the undersigned and the Rider.

The term "Rider" shall mean not only the undersigned, but also, any minor of the undersigned, and also any person who uses any portion of the property, equipment, horses or facilities of FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, with permission of the undersigned. Undersigned hereby releases FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, their agents, officers, directors, employees, trainers, successors, assigns, executors, heirs and administrators and any landowner from any and all claims, causes of action, demands, obligations and liabilities - which are now existing or hereafter mature or accrue at any time - arising out of or related in any fashion to the undersigned's or Rider's use of any FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, property, equipment, horses or facilities, except for FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC's gross negligence or FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC's, intentional acts. The term "Rider" shall also include: (child or children's name(s)).

The undersigned acknowledges and fully understands that Rider uses the property, equipment, horses and facilities of FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, at his or her own risk. The undersigned hereby agrees to hold and save FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, their agents, officers, directors, employees, trainers, successors, assigns, executors, heirs and administrators and any landowner harmless from each and every claim, demand, liability, or other obligation which may arise out of or be connected in any fashion with loss, injury or damage to the undersigned, to the undersigned's property, to the undersigned's children or anyone using (with the undersigned's or Rider's permission) any portion of the property, equipment, horses or facilities of FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC. The undersigned hereby agrees and covenants not to bring any action at law or in equity against FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, their agents, officers, directors, employees, trainers, successors, assigns, executors, heirs or administrators and any landowner on behalf of the undersigned or on behalf of Rider, whether minor or adult, arising from or relating in any fashion

to any injury, damage or other loss suffered by the undersigned or by Rider and connected in any fashion with the undersigned's or Rider's use of FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC's property, equipment, horses or facilities; and the undersigned shall further defend FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, their agents, officers, directors, employees, trainers, successors, assigns, executors, heirs and administrators and any landowner against any such actions brought by the undersigned or on the undersigned's behalf or brought by Rider or on Rider's behalf or brought by any other person with respect to the Rider's or undersigned's use of FLY HIGH FARM's, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC's, property, equipment, horses or facilities; and, furthermore, the undersigned shall indemnify FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, their agents, officers, directors, employees, trainers, successors, assigns, executors, heirs and administrators and any landowner for anything for which Rider is responsible either alone, jointly or severally.

The undersigned hereby forever releases FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, their agents, officers, directors, employees, trainers, successors, assigns, executors, heirs and administrators and any landowner from any and all claims, causes of action, obligations, responsibilities, demands, liabilities and damages - whether now existing or hereafter accruing or maturing at any time and in any way related to or arising out of training with ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, or FLY HIGH FARM whether at FLY HIGH FARM facilities, at a horse show, or elsewhere, or arising out of or related to FLY HIGH FARM, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC's training or riding the undersigned's horses whether at FLY HIGH FARM, at a horse show, or elsewhere. Furthermore, the undersigned shall defend FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, their agents, officers, directors, employees, trainers, successors, assigns, executors, heirs and administrators and any landowner against any and all such actions brought by the undersigned or on the undersigned's behalf or brought by Rider or on Rider's behalf or brought by any other person with respect to training received by Rider or Rider's horses at FLY HIGH FARM, at a horse show, or elsewhere.

The undersigned hereby acknowledges and understands that FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, NEW BEGINNINGS STABLE, LLC, their agents, officers, directors, employees, trainers, successors, assigns, executors, heirs and administrators and any landowner do not represent or warrant the quality or character of any horse furnished to Rider. Furthermore, the undersigned acknowledges and understands that horseback riding or other participation in activities at FLY HIGH FARM may involve substantial risk of bodily injury, death, property damage and other dangers

including, but not limited to, bodily injury or death resulting from kicks and bites, falling off horses or horses falling on Rider, being dragged by a foot caught in the stirrups, Rider being thrown by horse, equipment failure or collision with horses or vehicles or other inanimate objects.

In the event Rider or any of the designated individuals is a minor, the undersigned, on behalf of said minor, does hereby consent to any x-ray, anesthetic, medical or surgical diagnosis or treatment and hospital service that may be rendered to said minor under the general or specific instructions of any physician or hospital. The undersigned acknowledges that this consent to medical treatment is given in advance of any specific diagnosis or treatment which may be required, but is given to encourage FLY HIGH FARM, any hospital staff and physicians to exercise their best judgment as to the requirements of such diagnosis or treatment. The undersigned hereby agrees to pay all fees and expenses of doctors, hospitals, ambulances and other medical expenses reasonably and necessarily incurred.

READ CAREFULLY BEFORE YOU SIGN. THIS DOCUMENT RELEASES FLY HIGH FARM, MAXIMILIAN HIRSCH, DENISE C. HIRSCH, ELIZABETH D. HIRSCH, AND NEW BEGINNINGS STABLE, LLC, FROM ANY LIABILITY RESULTING FROM USE OF FLY HIGH FARM'S PROPERTY, EQUIPMENT, HORSES OR FACILITIES.

Fly High Farm Barn Rules

1. NO SMOKING anywhere on the property! NO EXCEPTIONS!
2. NO SPEEDING in the driveway and parking areas. Watch out for all children and animals!
3. Park in designated areas only.
4. No drugs or alcohol on the premises.
5. Hours of Operation:
 - Monday – Saturday; 9:00 AM – 9:00 PM
 - Sunday; 10:00 AM – 7:00 PM
6. Please do not bring your pets onto the property, nor even leave them in your car, truck, trailer, or your pocket.
7. All children under the age of 12 must be accompanied by and under the direct supervision of a Parent/Guardian. Older siblings may not be a Parent/Guardian substitute. The ONLY exception is a Rider participating in a lesson with Liz, that has a signed Rider Release Agreement on file.
8. Boarders are responsible for their friends, relatives and guests to comply with these rules.
9. No one may be on a horse without a proper, ASTM/SEI certified, rider safety helmet and it must always be securely affixed. Bicycle and skateboarding helmets are not an acceptable substitute.
10. Only mount a horse with a mounting block. No mounting a horse while in the barn.
11. All riding is restricted to the arena, round pen and the path between them and the barn. No riding off the property!
12. No one may jump a horse, without Liz being present.
13. Please don't use anyone else's tack, brushes, sprays, supplements, etc. without first obtaining their permission. If you absolutely must borrow something, make sure you return it cleaned and where it belongs. Please label your items (i.e. grooming supplies, halters and leads) to avoid confusion.
14. Please notify a member of management if you or your horse accidentally breaks something or is injured.
15. Basic manners & expectations:
 - a. If you open it, close it. If you walk by an open door or gate, and you know it should be closed, but you didn't open it...close it anyway.
 - b. If you unlock it, lock it back up.
 - c. If you turn it on, turn it off. If you walk by the water spicket and it's on, and you know it should be off, but you didn't turn it on...turn it off anyway.
 - d. If you borrow it, put it back where you got it from.
 - e. If you get it dirty, clean it (before you put it back).
 - f. If you see an empty water bucket or trough, then please fill it.
 - g. If your horse poops, clean it up.
 - h. If it doesn't concern you, then don't mess with it.
